- ~3.33 mn hectares of China's farmland is too polluted with heavy metals & other chemicals to grow crops
- Chinese cotton growers to plant 9% less in 2014 (10.5mn acres), making it the 3rd straight year of decline
- Middle route of S-N Diversion Project completed but MEP says only 10% of pollution targets met
- MEP to focus on cement, batteries & leather industries in anti-pollution drive
- Tiered tariffs for industrial & commercial users in 2014 for Beijing and Guangdong
- Guangdong: Water use expected to fall by 11%

- Shanghai: Wastewater from a water plant turns river bright 'sky blue' but officials says water meets standards
- Chongqing: RMB1.14bn for water & enviro protection of rural areas
- Hangzhou, Zhejiang: To reduce water use to <4.2bn cum by 2015
- Fujian Coast: Huge black water plume (~50 Olympic swimming pools) found; Greenpeace blames local textile industry
- Sinopec upgrades refinery to meet discharge standard for wastewater & water reuse
